Good afternoon

I am writing with regard to the submission deadline 2 for the Tees CCPP project. Redcar and Cleveland Borough Council are proposing to provide the following for this deadline;

- Local Impact Report
- Responses to first round of questions
- SOCG with the applicant

I can advise that attached is a copy of the Local Impact Report from the Council. There is potential for some additional information to be provided relating to economic benefits of the project, with this likely to be ready to submit tomorrow due to the relevant officer currently being on leave and only returning tomorrow. The Council may therefore provide the Inspector with an updated LIR, and would respectfully request that this be accepted notwithstanding the fact the deadline for submissions will have passed.

Attached is also a spreadsheet containing the responses to the first set of questions from the Inspector. There are again a few responses missing due to the officer being on leave as highlighted above. These responses again are hoped to be provided before the end of the week, and we would respectfully request that this be accepted notwithstanding the fact the deadline for submissions will have passed.
