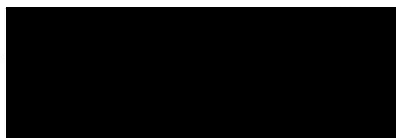
I write on behalf of Sembcorp Utilities (UK) Limited (the 'Applicant') in respect of Deadline 7 of the examination (the 'Examination') into the Tees Combined Cycle Power Plant Project (the 'Project').

Further to our letter dated 26 September 2018 and the update provided therein in respect of the Applicant's Statement of Common Ground ('SoCG') with the Environment Agency ('EA'), we now enclose a signed and fully agreed SoCG. For the avoidance of doubt, this includes an agreed position in respect of carbon capture and storage.

Importantly, the proposed text for Requirement 29 of the draft DCO (Application Document Ref: 8.62) has been subject to some minor amendments in the enclosed SoCG. The amendments were made to address comments from the EA and the text proposed in the SoCG now supersedes that set out in the latest version of the draft DCO (Application Document Ref: 8.62). It is therefore envisaged that the Applicant will submit a further update version of the draft DCO at Deadline 8.

We respectfully request that the enclosed SoCG is accepted as a late submission for Deadline 7. I would be grateful if you could confirm receipt of this letter.
