Application pursuant to Section 37 for a Development Consent Order in respect of the construction of Harbour Facilities at Bran Sands, Teesside

This letter accompanies an application submitted pursuant to Section 37 of the Planning Act 2008 ("the Act") seeking authorisation for a Harbour Facility, being a Nationally Significant Infrastructure Project complying with the criteria set out in Section 24 of the Act.

This application forms part of the wider York Potash Project which comprises the development of a new underground mine for the winning and working of polyhalite (a form of potash and a natural fertiliser) and its handling and transportation to the national and international market place. The Project comprises a cross boundary planning application in respect of a Mine (including minehead at Doves Nest Farm Nr.Whitby) and Mineral Transport System submitted to the North York Moors National Park Authority and Redcar and Cleveland Borough Council. It also includes an application for a Materials Handling Facility (submitted to Redcar and Cleveland Borough Council).

The position in relation to those applications, and other ancillary applications, is summarised in the Project Position Statement submitted with the application (Document 7.3). Some documentation submitted with the above mentioned applications, which sets out further information in respect of the wider project, is included as appendices to the Project Position Statement.

This application relates to the provision of the harbour for the export of polyhalite which will be transported to the harbour via an overland conveyor which will connect to the Materials Handling Facility at Wilton.

In summary, the application seeks consent for:

- The construction and operation of a quay structure on the River Tees at Bran Sands to facilitate
  the mooring of vessels in the estuary directly adjacent to an on-shore harbour facility and allow
  ship loader access;
- Dredging of the approach channel and berth pocket;

- The construction of ship loaders on the quay to load the mineral product on to ships for onward transmission;
- 4. The erection of surge bins for the ship loading flow management of the polyhalite;
- 5. A conveyor system to transport the polyhalite, connecting the harbour with the Materials Handling Facility within the Wilton International Complex; and
- 6. Ancillary Infrastructure.

The proposed development is more fully described in Schedule 1 of the draft Development Consent Order in conjunction with the Works Plans (Documents 4.1 and 2.2A-C). The parameters of the development, with which the development is required to conform, are referred to in Article 4 of the draft DCO and include a parameters table (Document 6.9), which is also crossed referred to in Schedule 1.

Enclosed is the York Potash Document List which sets out, for ease of reference, the documents which have been submitted with the application (Document 1.4). This lists the same documents that are set out in the Application Form (Document 1.1). In addition, enclosed, as Document 1.6, is an Issues and Documents Tracker which identifies the way in which the issues previously raised by the Inspectorate have been addressed.
