Detailed Planning Application: Land at South Tees Development Corporation East of Smiths Docks Road and West of Tees Dock Road South Bank

We are pleased to submit, on behalf of our client, South Tees Development Corporation ("the applicant"), "Teesworks", an application seeking full planning permission for the following development:

"Proposed extension to surface water management infrastructure"

Application Background

The South Bank site has benefited from Outline approval (R/2020/0357/OOM) since the 3 December 2020, permitting the following development:

"Outline planning application for demolition of existing structures on site and the development of up to 418,00 sqm (gross) of general industry (Use Class B2) and storage and distribution facilities (Use Class B8) with office accommodation (Use Class B1), HGV and car parking and associated infrastructure works. All matters reserved other than access"

This application follows on from the submission of applications R/2021/1096/CD and R/2022/0186/CD, which were submitted on 23 December 2021 and 24 February 2022, respectively.

The Application Proposals

This application seeks detailed planning permission for the extension of infrastructure that supports surface water management of the South Bank site.

Detailed technical drawings that were attached to planning application R/2021/1096/CD also accompany this application. These should be considered solely in the context of the area subject to the proposals and outlined on the attached Location Plan.
